# Contest Rules - The 2023 Golden Truth Ticket Sweepstakes & Giveaway

# 1. Eligibility

Golden Truth Ticket KIA Seltos Sweepstakes (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of CRUSADE Radio Guild and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

## 2. Sponsor

### 3. Agreement to Official Rules

### 5. How to Enter

On-Air Contest Tickets: Limit one (1) entry per person, for the duration of the Contest

Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

#### 6. Prize Drawing

On or about March 24, 2023, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend

on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about March 24, 2023. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

#### 7. Winner Notification

The potential winners will be notified by email, mail or phone. Each potential Grand and First Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. ### 9. General Conditions
