RADIO STATION AFFILIATE AGREEMENT


The **CRUSADE RADIO NETWORK** is a service of **BlackHat Studios, LLC**, a Louisiana LLC and the licensee of **The Mike Church Show**, Madisonville, Louisiana, hereinafter referred to as "CRN" with studios located at 217 Horned Owl Court, Madisonville, LA 70447.

(1) CRN will make "The Mike Church Show" hereinafter referred to as "The Program", a

- 3 Hour daily radio program that broadcasts live from 7-10am eastern, available (radio station) on a market exclusive basis, unless this agreement is otherwise amended. The affiliated Radio Station agrees to air this programming every weekday, Monday-Friday, in its entirety including CRN's must carry ads (TOH News is optional) as shown on the attached programming clock. Affiliate, at its discretion, may at times, pre-empt "The Program" for breaking news or other programming necessary to carry out the station's mission. (2) The affiliated Radio Station will provide a signed and dated copy of this affiliate agreement to CRN before broadcasting any program. (3) The affiliated Radio Station shall not defame CRN or other broadcasters who air shows on The CRUSADE RADIO NETWORK. (4) The affiliated Radio Station shall receive programming from the distribution systems listed below. (SELECT one or more): Live via CRN Internet Streaming Tape Delay via Dropbox Broadcaster will notify CRN of changes in Program broadcast time. (6) This agreement applies to the following AM/FM radio station: (7) CRN may request the broadcaster to furnish a monthly affidavit of program
